Dear Shareholders,

I am pleased to share an update on Dimension, Inc., and to reflect on what has truly been a monumental year for the company.

### **A Major Milestone: Issuance of Our Core Patent**

In September, Dimension reached a critical inflection point with the issuance of our Super-Resolution Enabled Codec (SREC) patent (U.S. Patent No. US12432388B2). This patent represents years of research and development and formally protects one of the most important technological advances in our portfolio. The issuance of this patent significantly strengthens Dimension's intellectual property position and validates the novelty and commercial relevance of our core technology.

### **Expanding and Strengthening Our Patent Portfolio**

In addition to the issued SREC patent, we currently have four additional utility patents pending, which further support and extend our technology platform. Together, these patents position Dimension as a company with a cohesive, defensible, and infrastructure-level IP portfolio, rather than a single-point solution.

More importantly, we now have a working demonstration of our upscaling technology, which can be shown to prospective partners and clients. This allows interested parties to see the practical, real-world impact of our technology rather than relying solely on theoretical descriptions.

### **Improved Visibility and Communication**

Following the first of the year, we will be updating the Dimension website to make our materials easier to access and understand. These updates will include:

- Clear presentation of our issued and pending patents
- Access to technical and executive-level documentation
- Demonstration materials for interested parties

We have already taken meaningful steps in this direction. A new video demonstration titled "What We Do" is now available on our website, offering a concise and accessible explanation of Dimension's capabilities.

In addition, we have published a new Executive Brief under the *Super-Resolution Enabled Codec* section of the site. This document provides a clear, non-technical overview of Dimension's technology and strategic positioning and is included at the end of this letter for your reference.

### **Strategic Focus and Market Readiness**



With our core patent now issued, additional patents pending, and demonstrations in hand, Dimension is entering a new phase. Our focus has shifted from primarily development to positioning the company for strategic partnerships, licensing opportunities, and potential transactions.

To support this effort, we have contracted with a professional promoter to assist in marketing the company and exploring pathways that may include partnerships, licensing arrangements, or a potential sale of the company or its technology. This step reflects our belief that Dimension's technology has reached a level of maturity and clarity that warrants broader exposure to qualified industry participants.

### **Looking Ahead**

Dimension today is in a stronger position than at any point in its history:

- We have issued IP protecting our core technology.
- Additional patents are moving through the pipeline.
- Demonstrations are available for real-world evaluation.
- Our messaging and materials are being refined for external audiences.
- We are actively pursuing strategic visibility and engagement.

While there is still work ahead, the foundation is now firmly in place. The progress made this year materially reduces execution risk and increases the range of strategic options available to the company.
